THE NAS DESIGN PARTNERSHIP AWARDS

WHAT IS IT?

A premier award which recognises excellence in interior design and shopfitting contracting with emphasis on the special partnership between designer/architect and contractor that shopfitting demands.

WHO ARE THE JUDGES?

The Judges represent interior designers, architects and contractors.

The panel for the 2012 Award will be under the Chairmanship of Howard Bates of Greig & Stephenson.

WHAT WILL THE JUDGES BE LOOKING FOR?

- Suitability of the design for its location, purpose and overall budget
- Strength of partnership between interior designer/architect and shopfitter
- Choice of materials
- Creativity and originality in interpreting the design brief and overcoming site conditions
- Special design features of functional or decorative relevance
- Quality of fit-out and project management

WHO CAN MAKE AN ENTRY?

- Interior designers
- Architects
- NAS members

If you do not fit into one of these sectors, please contact the NAS.

WHAT CAN I ENTER?

Any Retail, Non-Retail or Leisure fit-out. Projects must have been carried out by a member of the NAS within the European Economic Area and the fit-out must have been completed in the year 2011.

HOW DO I ENTER AND WHAT ARE THE DEADLINES?

STEP ONE:

You must register your intent by 5 pm on Monday 16 January 2012. To do this, please complete the first part of the entry form and return it to the NAS by fax/post.

STEP TWO:

The deadline is 5 pm on Monday 6 February 2012. You must complete the Entry Form and send it with the required additional material to the NAS.

Submit a CD of six hi-res jpeg/tif format images in either portrait or landscape that must be numbered in the order that the judges should view them. **The images should NOT be in a PowerPoint presentation.** The quality of the images is crucial to the judging process. The images should depict the fit out and not the client's merchandise.

Complete a précis (maximum two sides of A4 type) summarising the design brief, the design concept and particular factors about the partnership between interior designer/architect and shopfitter that brought added value to the client. These should be clear examples of partnership achievements that aided the final solution.

STEP THREE:

March 2012. You will be notified of the fact that you have been short-listed by 26 March 2012. All short-listed projects will be visited.

STEP FOUR:

May 2012. The notification and announcement of the winner will be made on 17th May 2012 at an Awards ceremony. Those shortlisted will have the opportunity to prepare an exhibit for display at the ceremony, to be held at the London Film Museum, Riverside Building, County Hall, Westminster Bridge Road, London SE1 7PB. All short-listed projects will also be featured in the 2012 edition of Shop Spec, the leading specification catalogue.
