## Vendor Agreement (Altius NAS PAS 82)

The **Vendor** accepts the terms and conditions below when completing an application and providing payment to Altius Vendor Assessment Limited for access to the Altius 'Gateway' website.

### 1. Definitions

- 1.1 **Vendor** shall mean a supplier, contractor or service provider that wishes to provide their **Vendor Assessment Information** to the **Altius Vendor Assessment 'Gateway' Website (Gateway)**, and thereby gain access to the National Association of Shopfitters (NAS) PAS 82 questionnaire.

- 1.4 The **Altius Vendor Assessment 'Gateway' Online PAS 82 Questionnaire** is a series of online questions, reflecting the current standards required by NAS for compliance with PAS 82, Shopfitting and interior contracting. Management system specification.

### 2. General Terms

- 2.1 Altius Vendor Assessment Limited agrees to make available to NAS, the results of the assessment and the **Vendor Assessment Information** provided by the **Vendor** through the **Altius Vendor Assessment 'Gateway' Online PAS 82 Questionnaire**, as required by NAS.
